



PERFORMANCE COMMENTARY

- a) Interest income increased by 25% from last year 2017 due to better returns on the Fixed Income assets.
- Cost income ratio improved from 13.4% in 2017 to 12.6% due to improved efficiencies. b)
- c) Members' contributions grew by 14% to Ushs 1.05 Trillion in 2018, while benefits paid increased by 29% to Ushs 359.7 Billion
- d) Unrealised income improved in line with growth of stock prices across the East African region. Depreciation of UGX also increased the UGX value of our investments in the region.
- e) Fund size stood at Ushs 9.9 Trillion, a growth of 26% from the prior year, due to the continued growth in investment assets and collections
 - Members' Fund interest expense was Ushs 1.1 Trillion compared to Ushs 681.4 Billion in 2017/6.

f) The financial statements were audited and signed by the Auditor General on 27th September 2017.
