The Bidding documents in English may be purchased by interested bidders on the submission of a written application to the address below at 8(b) and upon payment of a non-refundable fee of UGX 50,000. The method of payment will be by Bank to National Social Security Fund Account Number 9030005950790 at STANBIC BANK UGANDA LTD. The bidders shall then submit a deposit slip to the NSSF Finance Administrator on 14<sup>th</sup> Floor Southern Wing, Worker's House or email the receipt to <u>anasuru@nssfug.org copy procurement@nssfug.org</u>. The bidder shall be given an e-receipt on confirmation that funds have been transmitted into the specified account. The soft copy document will then be sent to the bidders or their representative (s) from NSSF Procurement and Disposal Unit at the address specified in 8(a) below

All bids must be accompanied with bid security of UGX 500,000 (Uganda Shillings Five Hundred Thousand Only) valid until and including October 10, 2024 in form of bank guarantee only.
